President's Report, Bill Loveday



Bicycle Queensland (BQ) has undergone significant changes in 2018. These are likely to continue in 2019. BQ has had new CEO Anne Savage settling

into her role with gusto to lead the organisation with her own inimitable flair. We have moved offices from West End to Milton and been punching above our weight in promoting and protecting bike riders and their interests on all fronts. Some commentators are now calling BQ the leading voice of cycling advocacy in the country due to its leadership and strong voice on cycling matters.

New CEO Anne began in late 2017 but 2018 has been her year of refreshing and invigorating BQ with external and internal changes. Outwardly BQ has now significantly more active social media presence, and is the go-to cycling organisation, on a State and National level, for comment from mainstream media. BQ is also working with State Government and other stakeholders to achieve real improvements in cycling safety and improved infrastructure.

Another important aspect of our work is to improve the road culture with moves to more consistent enforcement of the mandatory passing distance laws. This will improve cycling safety and help achieve cultural change in the minority of driving community that are unwilling to share the roads.

BQ has moved out of its West End home, where we have had offices over the last 20 years, to a new location in Milton. Furthermore, Anne in collaboration with the Management Committee has been re-shaping the organisation, building a new team, and reviewing our models of membership, events and advocacy to better achieve our mission.

Membership remains strong, with good retention of members and healthy numbers of new members joining BQ. However, there are immediate challenges for BQ with rising insurance premiums. We are looking for ways to improve coverage for members but also retain affordable membership costs. We appreciate the value members place on insurance and understand this is a key element of our membership package.

There have been ongoing declines in event participation, and while not losing money, these events are not as profitable as they were in previous years. There is a lot of competition in day riding events these days overall this is a good thing in terms of more people cycling. Our flagship events, the Great Brisbane Bike **Ride and Brisbane to Gold Coast** Cycle Challenge remain strong. The second Yarraman to Wulkuraka Rail Trail was a hit with all participants. Cycle Queensland went to North Queensland in 2018 and a great experience for all involved. Cycle Queensland will be re-imagined in a new format in 2019 to bring in new participants and keep people riding in different parts of the state.

In 2018 my thanks for support goes to the friends, sponsors and colleagues of BQ who contributed to making another successful year. CEO Anne and the BQ team's efforts in doing the spectacular and hard work to make the organisation work so well, in a year of so much change and many challenges, is truly inspiring.

Once again I thank our hundreds of volunteers, without whom, we could not do the great things that we do. Thanks to each and every one of you. A special thanks for those who came out in the rain for the Brisbane to Gold Coast Cycle Challenge.

To my colleagues on the Management Committee, Vice President, Fergus Hogarth, Secretary, Jenny Attreed, Treasurer, Brendan McGarry, and members Geoff Airo-Farulla, Audine Bartlett, Margo Hickman and Katie Panaretto – thanks for all your good work and help this year. Thanks and farewell to Geoff and Margo who are stepping down from Management Committee duties this year.

A very special thanks to retiring Secretary Jenny Attreed. Jenny has been on the BQ Management since the early 2000s and has been a tireless and dedicated servant of the organisation. Jenny been part of the stellar rise of BQ from a small scale community group to the significant organisation that it is today. Jenny also volunteered on many of our first cycling events and helped us establish Cycle Queensland. I acknowledge Jenny's great contribution to BQ and bike riding.

I also thank all BQ members for your continued support in 2018 and promise there will be more great things in 2019.

CEO's Report, Anne Savage



Thank you for your loyalty and support in 2018. Together we achieved some wonderful outcomes. We got funding for new regional bikeways, kick-started

work on a cycling tourism strategy, announced bike lanes from West End to the CBD on Brisbane Metro, gave our blessing for two new Indooroopilly Bikeway bridges, celebrated the completion of the world-class Brisbane Valley Rail Trail, and welcomed the start of construction on the Gabba Bikeway and new stages of the Veloway 1 – with the vision that it will eventually connect Brisbane and the Gold Coast.

With your backing, we took on some of the key challenges for safe cycling. We called for the creation of a Queensland Road Safety Commission, shone a spotlight on safe passing laws, secured safer speed limits, and fought every day to promote the protection of our members. We honoured our responsibility to you by creating the world's only 24/7 Cycling Incident Debrief Service, launching a smart phone app for cyclist safety, and ensuring you got fast and fair payouts on cycling insurance claims and benefits.

We also teamed up with Federal, State, and local government representatives to deliver improved outcomes and enhanced opportunities for cycling statewide, representing cyclists and vulnerable road users on a revitalised Queensland Cycling Advisory Group, the high-level Black Spot Consultative Committee and Safer Roads Sooner Advisory Committee, and Active Travel Leadership Groups in different regions.

Notably, we welcomed 2,095 new members during the year – reflecting a strong sense of value in our advocacy and outreach.

And yet, while 2018 was a year of hard-earned highs, it was also a year of agonising lows. Three of our members did not make it home. One of those was my friend and fellow advocate, Cameron Frewer, who was tragically killed when a car crashed into him on November 5.

To each of their families, I offer my deepest sympathy and my solidarity. The work we do every day is to honour their memory and to create a legacy whereby no other families have to



endure the unbearable heartache you have suffered.

To Bicycle Queensland's President Bill Loveday, Vice President Fergus Hogarth, and Management Committee – thank you.

To my team, who managed to hold it together in all kinds of weather, words aren't adequate to convey my appreciation and loyalty to you for your persistence and tenacity.

To our members, supporters, followers, and volunteers – thank you for giving me the opportunity to work every day for you. I have been carried by your words of encouragement, your calls for assistance, your expressions of concern for one another, and especially your strength and resilience. Your laughter keeps me going, your kudos lifts me up, and your love of cycling points me forwards.

I am abidingly grateful.
